IMPORTANT - USE OF YOUR INFORMATION

You are applying to enter into a credit agreement with us and in considering your application we will be using personal data about you. By signing this application you declare (where any joint applicant with you does not also sign) that you are entitled to disclose information about your joint applicant and any guarantor. You authorise us to search and / or record information about you and your joint applicant.
